3.1	Proof Of Hotel / accommodation, reservation in Thailand with contact number and address of accommodation.		
3.2	If travel in group, must provide a cover letter stating all names with passport numbers, plan of travel, and place(s) to stay.		
3.3	If intended to stay with relatives or friends, must provide invitation letter along with copy of their ID / passport and in case they are not Thai, must provide their work permit, valid at least six months.
